Dear Governor Dayton and Members of the Minnesota Legislature:

Going into the 2017 Legislative Session, you received a basket that included a budget surplus, low unemployment and sustained economic growth. From that position of strength, we heard from all sides that there was momentum (and resources) to set some priorities and make long-term strategic investments. As you evaluate the opportunities, we call upon you, our elected Governor and Legislators, to prioritize a transportation funding bill that funds and finishes the expansion plans for HWY 14 from New Ulm to Rochester.

Many of the jobs in the New Ulm area are connected to the manufacturing industry which depends on a safe, cost effective and efficient transportation system for the moving of employees and product. For the nearly 400,000 people living and working along the HWY 14 corridor, a completed four-lane highway connects the regional centers of New Ulm, Mankato, Owatonna and Rochester and provides the necessary and basic infrastructure for further development.

Dear Gov. Dayton, Sen. Newman and Rep. Torkelson,

At the beginning of the <u>2016</u> legislative session, the Rochester Area Chamber of Commerce communicated its priorities to our legislators in St. Paul. One of our top priorities was to create a long-term transportation infrastructure funding package that focuses on maintaining the system (roads and bridges). Although the legislature came very close to getting a funding package passed, eleventh hour partisan politics quashed those efforts and no progress was made.

Again in 2017, chambers of commerce across the state have rallied their members in support of transportation funding to address this essential need. Regional chambers asked the legislature to pass a long-term transportation bill that includes roads, bridges, airports and transit. In particular, we have focused the legislature on funding the long awaited travel and safety improvements on Highway 52, Highway 14 and across Southeast Minnesota.

Maintenance and improvement of our transportation infrastructure should not be a political football. It is not controversial or partisan. It is a key function and responsibility of our state and local governments. Our elected officials need to reach across the aisle and come together to do what is best for all of us.

Our manufacturing, agricultural and healthcare economies are dependent on our transportation infrastructure to get their products to market and patients to their critically needed services. Our businesses are reliant on our transportation infrastructure to get their employees to and from work. Without new investments to maintain and modernize our road, bridge and aviation systems, Minnesota risks losing out on future jobs and economic opportunities.

Our transportation system also plays a key role in the quality of life in our communities. Rochester was named the best city in America for the second consecutive year, and Southeast Minnesota is driving Minnesota's economy. We all have places to go and want to see our friends and family members arrive at their destinations safely, but our roads are becoming less safe with traffic accidents and fatalities on the rise across Minnesota. We are keenly aware of the need for a long-term transportation plan to ensure we have the ability to serve the future visitors and residents of Southeast Minnesota.

The need for increased investment is not debatable. Additional dollars are needed to improve our airports and the condition of our roadways and bridges. As the legislative session enters its final stretch, we need to remind legislators and the governor that our transportation system needs are not going away. Our state government needs to work together to fulfill its responsibility. Our representatives need to assure us that a long-term plan will be put into place, starting this year, so we can be confident that needed infrastructure investments will be made.

We implore our elected officials to come together and not allow political in-fighting to stifle our current and future success.
